Introduction

The diversity data has been collated in accordance with the Bar Standards Board (BSB) handbook, Rules on Equality and Diversity. This data was collected in October 2020, the next collection date will be before October 2023.

A total of 71 members, and staff were sent the survey to complete and of those 58 people (82%) responded.

The results are based on the number of voluntary responses received. Our Data Diversity Policy and the BSB requirements stipulate that data will **NOT** be published where there are fewer than ten individuals within a particular job category with the same relevant characteristics, unless each of those individuals has consented. The entry 'unable to publish' reflects the application of this restriction. Anonymity is the priority, where it has been requested.
