The FIA operates in 145 countries, has 245 member organisations, and represents 80 million motorists. It governs motor sport and F1, campaigns on safety, and promotes mobility. Graham has unparalleled highlevel experience in motor sport and automotives, and in world sport governing bodies. He has pioneered social responsibility and sustainability, education and training, and the importance of the global motor sport industry. He is also an International Lawyer and expert in governance.

Graham rose to run the UK Motorsport National Federation, securing the future of the British Grand Prix, Wales Rally GB, and other key events, developing the sport, and representing the 750 member organisations throughout the UK.

He was elected to the FIA World Motor Sport Council in 2007, and then elected as FIA Deputy President in 2009, the highest position in motorsport, and was re-elected for three terms to 2021.

He has extensive experience as Non-Executive Board Member and Chairman. He is a former member of the IOD.

Member of the Environmental Bar Association. Member of UK Parliamentary Bar. Member of the Bar Sports Law Group. Graham has been in a leading position in motor sport for over 25 years and from 2009 until 2021 he has been Deputy President for Sport of the Fédération Internationale de l'Automobile, the FIA, the world governing body and ultimate owner of F1 based in Paris and Geneva, an NGO affiliated with the UN, and the IOC. This is the highest sporting governance position in world motor sport and Graham has been the longest serving Deputy President in the history of the Global Federation.

During Graham's three terms of office, he established a range of progressive programs including global sport development, and sustainability programs, and he attended and spoke at COP 26. He established Women in Sport programs, STEM education, inclusivity, and a human rights initiative "Purpose Driven", and worked with the UN to foster peace through sport. He established worldwide education and training programs. oversaw the organisation of annual Global Conference's, and Regional Conference's, and he has unique experience at the highest levels of World Sport, dealing with the IOC, Youth Olympic Games, Global Association of International Sport Federations and CAS, and holds a respected international reputation.

In the complex world of commercial rights Graham has been involved in the negotiation of five versions of the F1 "Concorde Agreement", together with the selection of new F1 Teams, and the multibillion-dollar sale of the commercial rights of F1 in 2006 and again in 2017. He was also involved in the "Spygate" hearings leading to the record 100 million dollar fine, ultimately used for sport development (BBC Sounds "Spygate: The scandal that shook F1 to its core")

## The Pandemic

Graham returned from the Covid outbreak and cancelled 2020 Australian Grand Prix to grapple with the unprecedented impact of the Covid Pandemic on global motorsport. He established a solidarity program to support FIA members through the pandemic, with no national federation being lost, established regular focused web seminars and training, and with the help of the WHO set up an acclaimed return to motorsport plan. Graham travelled through the pandemic under an international sport leader exemption and covid passport. Motorsport was one of the first major sports to resume, and the protocols became best practice for other sport federations wishing to restart their sports.

## **Presidential Campaign**

Graham also mounted a respected presidential campaign in 2021 for the FIA Presidency, presenting an acknowledged strong "Presidential List", gaining the support of the major motorsport countries such as Italy, France, Germany, Finland, Norway, Argentina, Mexico, Singapore, Japan, and the USA. Through the global campaign he gained high level experience of public relations, social media, TV interviews, podcasts, and political campaign strategy. He is an experienced world traveler having visited over 50 countries and has an established and active global contact list amongst world leaders.
