£408,350 in fines for 45 breaches of fishing law

THE owners, charterers and masters of the fishing vessels Playa Uno, Playa Dos and Playa de Tambo have been fined a total of £408,350 for 45 offences breaching fishing legislation, in the Magistrates Court.

confiscation order of £154,971.77 was also ordered the vessel against owners Pesquerias Marinenses SA as well as the value of the fish seized from Playa Uno and Playa Dos.

An agreement has been reached as to how the value of the seized fish will be calculated. The fish has been stored by SAAS at an estimated cost of £200,000 to Government to date.

The five defendants were each ordered to pay £2,000 costs with all to be paid within two months.

Guilty pleas were entered on Friday February 26, when Crown Prosecutor Stuart Walker offered no evidence on a further six charges relating to unlicensed fishing which if proven could have resulted in forfeit of the vessels estimated at a value of between £2.5 to £3 million each.

Given the early guilty pleas on the licence breach offences he said it was not in the public interest to pursue them further.

He said the guilty pleas now entered "reflected the criminality of the offences.'

The vessels are chartered by local company FIBOW Ltd a subsidiary of Seafish Ltd.

When catch verification took place after they were brought in for inspection in July last year, Playa Uno and Playa Dos had been found to have nearly 100 tonnes more hake on board between them than had been declared and over 35 tonnes less rock cod than declared.

fishing legislation vessels are required to file accurate fishing commencement reports, the amount of fish currently stored on the vessel, and a fish end report as well as daily catch reports.

Pesquerias Marinenses was fined a total of £200,000 for two offences of fishing without a licence; 12 offences of providing false reports and one of the master of Playa Dos not holding a Overseas Master fishing licence.

FIBOW Ltd was fined a total of £190,000 for the same offences and as the charterer did not stand to receive any benefit from the false reporting, said Senior Magistrate Clare Faulds, adding however, "had the information been dealt with properly, would soon have realised that the reports

The Playa de Tambo (licensed to fish for skate) had reported more hake (1%) than it had actually caught but under reported on the rock cod, and the master, as the least serious offender, was fined £200 for each of the three offences of misreporting.

Playa Uno and Dos held restricted finfish licenses which did not include the more valuable hake and the masters were fined £9,500 and £8,250 respectively.

Senior Magistrate Clare Faulds said that the masters of Playa Uno and Dos had shown "cavalier attitudes" to the need to keep within the terms of licence and "worrying disregard," for the need to report accurately.

"It stretches credulity that these under-reporting of hake were

accidental or simple error," said Mrs Faulds.

This was a first offence for both owners and charterers who have operated in Falklands waters for some 19 years.

Director of Natural Resources John Barton commended the fishery officers and other staff within the Fisheries Department involved in getting the cases to this stage. "It involved a lot of detailed work," he told Penguin News.

decision on licensing will be a decision for the Director of Natural Resources.
